WHEREAS, the parties hereto representing more than seventy-five percent (75%) of all owners now existing in "BUTLER FARM ESTATES" legally described as all of Concho Valley Estates, Section One, as per the map or plat of record in Vol. 313, Page 890, Official Public Records of Real Property of Tom Green County, Texas, are desirous of amending and correcting the Amended Declaration of Use, Covenants, Conditions and Restrictions of Concho Valley Estates, Section One, recorded in Vol. 526, Page 931, Official Public Records of Real Property of Tom Green County, Texas;

NOW THEREFORE, the undersigned hereby declare the following amendment and correction to the Amended Declaration of Use, Covenants, Conditions and Restrictions of Concho Valley Estates, Section One, recorded in Vol. 526, Page 931, Official Public Records of Real Property of Tom Green County, Texas.

Article III. Use Restrictions. Section 3. Page 5 is amended and corrected to read as follows:

Any residence building constructed on a lot must contain a minimum of 2500 square feet. At least three of the exterior walls of any residence building must consist of at least fifty percent (50%) brick. ~~OR~~ masonry.

Said amendment and correction shall run with the real property and be binding upon all parties having or acquiring any right, title or interest in a lot, their heirs, successors and assigns, and shall inure to the benefit of each Owner thereof. The undersigned hereby adopt, ratify and retain the Amended Declaration of Use, Covenants, Conditions and Restrictions of Concho Valley Estates, Section One, recorded in Vol. 526, Page 931, Official Public Records of Real Property of Tom Green County, Texas, in all respects, except for the amendment and correction declared herein.

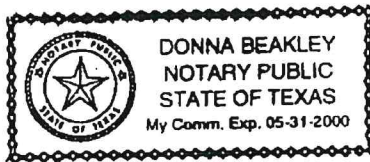
